

RCS Store Cards R2 500 Shopping Voucher Competition 1 July – 31 October 2026

- 1.** This competition is organised by RCS Cards Proprietary Limited (“RCS”/ the “Promoter”) (NCRCP 38/FSP 44481). (“the Promoter”)
- 2.** Participation in this competition constitutes an agreement to abide by the rules herein and you further bind yourself to the extent lawfully permissible.
- 3.** Competition period: The competition commences on Wednesday, 1 July 2026 and will terminate at 23h59 on Saturday, 31 October (the “Competition period”).
- 4.** Prize Details: Stand a chance to win a R2 500.00 Shopping Voucher (the “Prize”). 1 (one) Prize will be given away to a different, randomly selected winner at the end of every month for the duration of the competition.
- 5.** Service to which Competition relates: Valid online purchase to the value of at least R 500.00 made using the RCS store card in the RCS network during the competition period.
- 6.** How to qualify: All customers must abide by the below points to qualify:
 - Must be an RCS store card account holder;
 - This competition applies only to customers using any RCS store card within the Republic of South Africa.
 - Must spend R500.00 or more online using any RCS store card in the RCS network during the Competition period.
 - The transaction will result in automatic entry to win and there is only one valid entry to the draw of the winner.
 - Conclude a Qualifying Transaction during the Competition Period, which transaction must not be declined, cancelled, or refunded during the Competition Period or before the winning Participant has been selected. Should the qualifying transaction be declined, cancelled or refunded within the Competition period or before the winning participant has been selected, this transaction shall be deemed an unsuccessful purchase and the participant’s automatic qualification will be deemed null and void.
