

RCS R25 000 Samsung Home Appliances Competition 1 -31 December 2024

1. This competition is organised by RCS Cards Proprietary Limited (“RCS”/ the “Promoter”) (NCRCP 38/FSP 44481) (“the Competition”).
2. **Participation in this competition constitutes an agreement to abide by the rules herein and you further bind yourself to the extent lawfully permissible.**
3. **Competition period:** The competition commences on **Sunday, 1 December 2024 and will terminate at 23h59 on Tuesday, 31 December** (the “Competition Period”).
4. **Prize Details:** The Prize consists of Samsung home appliance/s, with a maximum total value of R25 000 (twenty five thousand rand) (the “Prize”).
5. **How to qualify:** The following criteria must be met to participate in the Competition:
 - 5.1. The participant must be an RCS Store Card account holder.
 - 5.2. The Competition only applies to customers using their RCS Store Card within the Republic of South Africa.
 - 5.3. The participant must spend R1 000 (one thousand rand) or more online using their RCS Store Card during the Competition Period.
 - 5.4. All eligible participants who comply with the entry mechanism of the Competition will automatically be entered into the Competition and stand a chance to win the Prize. There is only one valid entry to the Competition per participant.
